At a regular meeting of the Township Board for Grattan Township held at the Township offices within the Township on February 13, 2023, at 7:00 p.m., the following Ordinance/ordinance amendment was offered for adoption by Township Board Member Frank Force and was seconded by Township Board Member Sabrina Freeman:

AN AMENDMENT TO THE GRATTAN TOWNSHIP ZONING ORDINANCE AND ZONING MAP TO REZONE THE PROPERTIES WITHIN GRATTAN TOWNSHIP COMMONLY KNOWN AS 12151 AND 12355 JENKS STREET AND ALSO AS PERMANENT PARCEL NOS. 41-12-03-126-006 AND 41-12-03-101-002 (AND OWNED BY THE MARGOT JENKS TRUST) FROM THE PRIOR A-1 AGRICULTURAL ZONING DISTRICT DESCRIPTION TO THE A-2 AGRICULTURAL ZONING DISTRICT.

THE TOWNSHIP OF GRATTAN (the "Township") ORDAINS:

<u>Article1</u>. The properties located within Section 3 of Grattan Township commonly known as 12151 AND 12355 Jenks Street and also as Permanent Parcel Nos. 41-12-03-126-006 and 41-12-03-101-002 (and as legally described below) are hereby rezoned from the prior A-1 Agricultural zoning district designation to the A-2 Agricultural zoning district designation, such that both the Grattan Township Zoning Map and the Grattan Township Zoning Ordinance are revised and amended accordingly:

Should a court of competent jurisdiction determine that any portion of this Ordinance/ordinance amendment (or any portion thereof) is invalid or unconstitutional, that shall not affect the balance of this Ordinance/ordinance amendment, which shall remain in full force and effect.
- <u>Article 7.</u> <u>Effective Date.</u> This Ordinance/ordinance amendment shall become effective upon the expiration of seven (7) days after this Ordinance/ordinance amendment or a summary thereof appears in the newspaper as provided by law.
