At a regular meeting of the Township Board for Grattan Township held at the Township offices within the Township on March 13, 2023, at 7:00 p.m., the following Ordinance/ordinance amendment was offered for adoption by Township Board Member Michelle Alberts and was seconded by Township Board Member Paul Knoerl:

AN AMENDMENT TO THE GRATTAN TOWNSHIP ZONING ORDINANCE AND ZONING MAP TO REZONE THE PROPERTIES WITHIN GRATTAN TOWNSHIP COMMONLY KNOWN AS 13331 BELDING RD, PERMANENT PARCEL NO. 41-12-14-200-011 (AND OWNED BY H&W FARMS) FROM THE PRIOR A-1 AGRICULTURAL ZONING DISTRICT DESCRIPTION TO THE A-2 AGRICULTURAL ZONING DISTRICT.

## THE TOWNSHIP OF GRATTAN (the "Township") ORDAINS:

<u>Article1</u>. The property located within Section 14 of Grattan Township commonly known as 13331 Belding Rd and also as Permanent Parcel No. 41-12-14-200-011 (and as legally described below) are hereby rezoned from the prior A-1 Agricultural zoning district designation to the A-2 Agricultural zoning district designation, such that both the Grattan Township Zoning Map and the Grattan Township Zoning Ordinance are revised and amended accordingly:

Article 5. The Remainder of the Grattan Township Zoning Ordinance and Zoning Map are Unaffected. Except as expressly amended by this Ordinance/ordinance amendment, the rest of Grattan Township Zoning Ordinance and Zoning Map remain unchanged and in full force and effect.

<u>Article 6</u>. <u>Severability</u>. Should a court of competent jurisdiction determine that any portion of this Ordinance/ordinance amendment (or any portion thereof) is invalid or unconstitutional, that shall not affect the balance of this Ordinance/ordinance amendment, which shall remain in full force and effect.

<u>Article 7</u>. <u>Effective Date</u>. This Ordinance/ordinance amendment shall become effective upon the expiration of seven (7) days after this Ordinance/ordinance amendment or a summary thereof appears in the newspaper as provided by law.
